Course Description

This is an introductory Ph.D. level course in microeconomic theory. The course will focus on partial equilibrium, consumption, production and uncertainty. The aim of the course is to provide you with the tools and the intuition for basic economic modeling. The topics covered should be similar to those in an intermediate level course for undergraduates, but at a much higher level of rigor.

Prerequisites

You should have had a course in microeconomic theory at the undergraduate level. You also should be familiar with the mathematical concepts covered in EC 570 or currently enrolled in that class. This course is not recommended for students pursuing a Masters degree only. [It is an introductory class, not a capstone one!]

Grades

There will be two in-class exams, each counting for 40% of your total grade. Homework problems will count for the remaining 20%. You are encouraged to work together on homework problems, but the work you write-up to hand in must be your own.

Make-up exams and attendance: Every missed exam or assignment receives a grade of zero unless explicitly exempted by the professor. All requests for an exemption and/or make-up assignment must be requested in writing (e-mail is sufficient) at the earliest feasible time.
